Impact of Week 53

The New Carlsbad Inn

If it's been a while since your last visit to the resort, you will be surprised to see what has really become the new Carlsbad Inn. The Lobby and Library updates were completed by the end of last summer. All of the Oak condos received new paint, trim, furniture, carpet and draperies, with work completed last October. By now most of our Owners have seen and experienced the benefits of the renovation efforts.



The central courtyard received a major overhaul this last spring and the change is dramatic! The addition of a large patio with two fire pits and a fountain is certainly a major improvement in looks and how it changes the atmosphere of the area. Throughout the summer, it was great to see families mingling in a renewed community setting, sharing and enjoying each others company gathered around the new fire pits after sunset.

In addition, nearly all the existing plant material was removed and replaced

with a completely new landscape theme. The tall bushes have been replaced with lower shrubs that open up views and add light to first floor units. Iron fences gave way to glass walls that make it possible to see the ocean from all locations around the center of the resort. The side benefit is that all the new plantings are water wise and will require less frequent replacements to cut back on annual expenses.
